FORM OF COMPULSORY PURCHASE ORDER UNDER SECTION 76 OF AND THE THIRD SCHEDULE TO THE HOUSING ACT, 1966, AS EXTENDED BY SECTION 10 OF THE LOCAL GOVERNMENT (NO. 2) ACT, 1960 AND AMENDED AND EXTENDED BY THE PLANNING AND DEVELOPMENT ACTS, 2000-2018 INCLUDING SECTION 213 OF THE PLANNING AND DEVELOPMENT ACT, 2000; LOCAL GOVERNMENT ACTS, 1925-2014 INCLUDING LOCAL GOVERNMENT (NO.2) ACT, 1960; ROADS ACTS 1993-2015, AND ALL OTHER ACTS.

SECTION 10 OF THE LOCAL GOVERNMENT (IRELAND) ACT, 1898, AS AMENDED BY SECTION 11 OF THE LOCAL GOVERNMENT (NO. 2) ACT, 1960 AND SECTION 213 OF THE PLANNING AND DEVELOPMENT ACTS, 2000-2018

WHEREAS in pursuance of section 10 of the Local Government (No. 2) Act, 1960, as substituted by section 86 of the Housing Act, 1966 as amended by section 6 and the Second Schedule to the Roads Acts, 1993-2007 and by the Planning and Development Acts, 2000-2018, the Kilkenny County Council (hereinafter referred to as "the local authority") has decided to effect the acquisition of the land to which this order relates under the Housing Act, 1966:

NOW THEREFORE it is hereby ordered that—

1. Subject to the provisions of this order, the local authority is hereby authorised—

- (a) to acquire compulsorily for the purposes of the construction of the Proposed N24 Tower Road Junction Improvement Scheme (Garrynarea to Belline and Rogerstown) through the townlands of Tibberaghny, Garrynarea, Belline and Rogerstown with ancillary works, the land described in Part I of the Schedule hereto which land is shown on maps marked **Kilkenny County Council Compulsory Purchase Order No. 3 of 2019 Proposed N24 Tower Road Junction Improvement Scheme (Garrynarea to Belline and Rogerstown)** and sealed with the seal of the local authority and deposited at the offices of the local authority (hereinafter referred to as "the deposited maps"), and
- (b) to extinguish the public rights of way described in Part II of the Schedule hereto by order made after the acquisition of the land, where the said public right of way is over the land so acquired or any part thereof, or over land adjacent to or associated with the land so acquired or any part thereof.

2. The land described in Part I of the Schedule hereto and coloured grey on the said maps is land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.

3. Subject to any necessary adaptations, the provisions of —

(a) the Lands Clauses Acts (except sections 127 to 132 of the Lands Clauses Consolidation Act, 1845, and article 20 of the Second Schedule to the Housing of the Working Classes Act, 1890), and

(b) the Acquisition of Land (Assessment of Compensation) Act, 1919, as amended by the Acquisition of Land (Reference Committee) Act, 1925, the Property Values (Arbitrations and Appeals) Act, 1960, and the Local Government (Planning and Development) Act, 1963 (as applied by section 265(3) of the Planning and Development Acts, 2000-2018), as modified by the Third Schedule to the Housing Act, 1966, are hereby incorporated in this order and the provisions of those Acts shall apply accordingly.

4. This order may be cited as the **Kilkenny County Council Compulsory Purchase Order No. 3 of 2019 Proposed N24 Tower Road Junction Improvement Scheme (Garrynarea to Belline and Rogerstown).**

1. The section of National Road N24 in the Townlands of Garrynarea, Tibberaghny and Belline & Rogerstown between the lines 1 – 1 and 1A – 1A, for a distance of 664m.
2. The section of Local Primary Road LP1038 in the Townlands of Garrynarea and Belline & Rogerstown, between the lines 2 – 2 and 2A – 2A, for a distance of 254m.
3. The section of National Road N24 in the Townlands of Belline and Rogerstown between the lines 3 – 3 and 3A – 3A, for a distance of 670m.
4. The section of Local Tertiary Road LP42221 in the Townland of Tibberaghny, between the lines 4 – 4 and 4A – 4A, for a distance of 28m.
5. The section of Local Primary Road LP4222 in the Townlands of Belline and Rogerstown, between the lines 5 – 5 and 5A – 5A, for a distance of 190m.
6. The section of Local Primary Road LP1039 in the Townlands of Belline and Rogerstown, between the lines 6 – 6 and 6A – 6A, for a distance of 78m.
7. The section of National Road N24 in the Townlands of Belline & Rogerstown between the lines 7 – 7 and 7A – 7A, for a distance of 475m.
