COMPULSORY PURCHASE ORDER UNDER SECTION 76 OF AND THE THIRD SCHEDULE TO THE HOUSING ACT, 1966,

AS EXTENDED BY SECTION 10 OF THE LOCAL GOVERNMENT (NO. 2) ACT, 1960 AND AMENDED AND EXTENDED BY THE PLANNING AND DEVELOPMENT ACTS, 2000 (As Amended)

INCLUDING SECTION 213 OF THE PLANNING AND DEVELOPMENT ACTS, 2000 (As amended);

LOCAL GOVERNMENT ACTS, 1925 - 2019 INCLUDING LOCAL GOVERNMENT (No. 2) ACT, 1960; ROADS ACTS 1993 - 2015, AND ALL OTHER ACTS.

SECTION 10 OF THE LOCAL GOVERNMENT (IRELAND) ACT, 1898, AS AMENDED BY SECTION 11 OF THE LOCAL GOVERNMENT (NO. 2) ACT, 1960 AND SECTION 213 OF THE PLANNING AND DEVELOPMENT ACTS, 2000 (As amended).

WHEREAS in pursuance of section 10 of the Local Government (No. 2) Act, 1960, as substituted by section 86 of the Housing Act, 1966 as amended by section 6 and the Second Schedule to the Roads Acts, 1993 - 2015 and by the Planning and Development Acts, 2000 (As Amended), the **Kilkenny County Council** (hereinafter referred to as "the local authority") have decided to effect the acquisition of the land to which this order relates under the Housing Act, 1966:

NOW THEREFORE it is hereby ordered that—

- 1. Subject to the provisions of this order, the local authority are hereby authorised—
 - (a) to acquire compulsorily for the purposes of the construction of the N24 Carrick Road Improvement Scheme, (Clonmore to Mooncoin) through the townlands of Clonmore, Grange, Pollrone and Mooncoin with ancillary works the land described in Part I of the Schedule hereto which land is shown edged red and coloured pink which consists of a house unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense on a map marked Kilkenny County Council Compulsory Purchase Order No. 5 of 2022 N24 Carrick Road Improvement Scheme (Clonmore to Mooncoin) and sealed with the seal of the local authority and deposited at the offices of the local authority (hereinafter referred to as "the deposited map"),

and,

- (b) to acquire compulsorily for the purposes of the construction of the N24 Carrick Road Improvement Scheme, (Clonmore to Mooncoin) through the townlands of Clonmore, Grange, Pollrone and Mooncoin with ancillary works the land described in Part II of the Schedule hereto which land is shown edged red and coloured grey on a map marked Kilkenny County Council Compulsory Purchase Order No. 5 of 2022 N24 Carrick Road Improvement Scheme (Clonmore to Mooncoin) and sealed with the seal of the local authority and deposited at the offices of the local authority (hereinafter referred to as "the deposited map"), and.
- (c) to acquire compulsorily for the purposes of the construction and maintenance of the N24 Carrick Road Improvement Scheme, (Clonmore to Mooncoin) through the townlands of Clonmore, Grange, Pollrone and Mooncoin with ancillary works the permanent wayleave described in Part III of the Schedule hereto, which permanent wayleave is shown edged red and coloured yellow on a map marked Kilkenny County Council Compulsory Purchase Order No. 5 of 2022 N24 Carrick Road Improvement Scheme (Clonmore to Mooncoin) and sealed with the seal of the local authority and deposited at the offices of the local authority (hereinafter referred to as "the deposited map"). The permanent wayleave shall convey the right for Kilkenny County Council, their agents, officers, servants, workmen, contractors, licensees, invitees and any other persons authorised by Kilkenny County Council:
 - (i) to construct, lay, keep, operate, maintain, renew, repair and inspect the drains and all associated physical elements as provided under section 76 of the Roads Acts 1993 (as amended) used for the collection and conveyance of surface water and such other works and things as are necessary or expedient in relation thereto or are ancillary thereto or form part of such surface water drainage system in, on or under the land specified in Schedule Part III below, together with the right,
 - (ii) to enter with all necessary vehicles, plant and machinery upon said land at all times for any of said purposes.

and,

- (d) to extinguish the public right of way described in Part IV of the Schedule hereto by order made after the acquisition of the land, where the said public right of way is over the land so acquired or any part thereof, or over land adjacent to or associated with the land so acquired or any part thereof.
- 2. (a) The land described in Part I of the Schedule hereto and coloured pink on the deposited map consists of a house unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.
 - (b) The land described in Part II of the Schedule hereto and coloured grey on the said map is land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.
 - (c) The land described in Part III of the Schedule hereto and coloured yellow on the said map is land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.
- 3. Subject to any necessary adaptations, the provisions of—
- (a) the Lands Clauses Acts (except sections 127 to 132 of the Lands Clauses Consolidation Act, 1845, and article 20 of the Second Schedule to the Housing of the Working Classes Act, 1890), and
- (b) the Acquisition of Land (Assessment of Compensation) Act, 1919, as amended by the Acquisition of Land (Reference Committee) Act, 1925, the Property Values (Arbitrations and Appeals) Act, 1960, and the Local Government (Planning and Development) Act, 1963 (as applied by section 265 (3) of

the Planning and Development Acts, 2000 (As Amended), as modified by the Third Schedule to the Housing Act, 1966 are hereby incorporated in this order and the provisions of those Acts shall apply accordingly.

4. This order may be cited as the **Kilkenny County Council Compulsory Purchase Order No. 5** of 2022 N24 Carrick Road Improvement Scheme (Clonmore to Mooncoin)
